**SHOW- CAUSE NOTICE FOR DE-AFFILIATION OF TRADES/UNITS.**

Whereas, the Writ petition no. **3721/2019** was filed by you for quashing of de-affiliation orders dated 13<sup>th</sup> September, 2018 and 18<sup>th</sup> March, 2019, passed by the this Directorate General.

2. Whereas, in compliance with the interim order dated 08.05.2019 passed by the Hon'ble Delhi High Court, an inspection was carried out by the Joint inspection team on 31.05.2019 which adverts to various deficiencies (**copy enclosed**) as mentioned below:-

In view of above and also in compliance of the judgment dated 27.08.2019 passed by the Hon'ble High Court of Delhi you are requested to clarify why the de-affiliation orders dated 13<sup>th</sup> September, 2018 and 18<sup>th</sup> March, 2019 should not be acted upon. The reply must reach this office **within a week** of receipt of this show cause notice.
