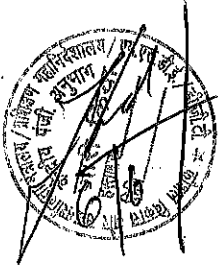

The reply must reach this office within 15 days of the issue of this letter.



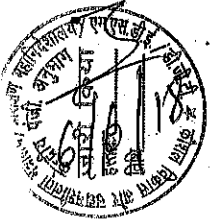


Sir/ Madam,

This office is in receipt of a letter no. D/Surprise visit/2018, dated 23-03-2018, from the Commissioner, Employment & Training of Telangana State, forwarding therewith the inspection report of the above mentioned ITI. The State Directorate has informed that during inspection they have found Irregularities such as **two institute running in same building, no 3 phase power supply. Single phase electrical bill submitted. Required power supply is 17.44 KW but only 5 KW available, No equipment for the fitter trade as per norms. Equipment available for only one Unit in Electrician trade out of the 4 units. No Class rooms for the both the trades i.e. Electrician and Fitter trade. No space as per norms, required area is 833.74 sq. mtrs but available is 601.948 mtrs for G+2 floors. Workshop should be located in ground floor but it is in 2<sup>nd</sup> floor. Technical Staff in not available as per norms. etc.** A copy of letter is enclosed. Accordingly, the State Directorate has recommended for De-affiliation of your ITI from the NCVT affiliated trade/units.

Therefore, you are requested to clarify why action should not be initiated to de-affiliate your institute.
