Reference court case compliance of common judgement dated 07.08.2017 passed by the Hon'ble the Acting chief Justice Ramesh Ranganathan and the Hon'ble Ms. Justice J.Uma Devi in W.A. Nos.979,983,989,990 & 991 of 2017 & WP.Nos.21279,21282,21283,21153 & 21181 of 2017-regarding.

2. DGT letter no. DGT-HC034/1/2017-O/o DD (TC)-Part (1), dated 11th Sept 2016/2017.

Sir,

Kindly refer the above matter wherein this office had forwarded the shortcomings/Remarks of 08 Private ITIs of your State vide letter no DGT-HC034/1/2017-O/o DD (TC)-Part (1) dated 11th Sept 2017. These 8 ITIs, as well as Vidhayarti & Rajiv Gandhi Pvt ITI, were asked to rectify the deficiencies within three weeks from receipt of the said letter. These 10(8+2) ITIs were also asked to intimate this office that they have complied with the deficiencies pointed out in that report. Hon'ble court had given them 10 weeks' time for intimate in the matter.

In this regard, it is to inform you that, two more Pvt. ITIs Suhana Pvt ITI & Venus Pvt ITI have now informed this office vide letter no. nil dated 19.06.2018 that they have rectified the deficiency (copy of letter attached).

You are also requested to get these 02 Institutes re-inspected as per decision of Hon'ble High Court of Hyderabad (copy of judgment attached) & inform DGT regarding the decision for de-affiliation of these 02 ITIs so that necessary action initiated accordingly, at the earliest in order to comply with Hon'ble High Court judgment.


The reply of 02 ITI(s) (Vidyarthi Pvt. ITI & Rajiv Gandhi Pvt. ITI) received at DGT along with remarks of these 02 ITIs & main inspection report / comments were forwarded to your office vide letter no DGT-40(6)/De-affiliation/2016-TC (Telangana) dated 03.05.2018.

In addition to above; two more Pvt ITIs Suhana & Venus Pvt ITI have also now submitted their reply alongwith the compliance.

You are requested to get these 4 ITIs re-inspected (as per the decision of Hon'ble High court of AP, & inform DGT regarding your observation/comments regarding de-affiliation of these ITIs at the earliest.

Based on your recommendation, DGT would initiate further necessary action in the matter of de-affiliation of these 04 ITIs.
