As you are aware that any public building has to conform to the local bylaws, duly certified and approved by the local planning authority (Municipal Councils/Municipal Corporation/Collector). However, in case of the ITI buildings, these bylaws are either overlooked or not followed in essence.

It has been therefore decided that now onwards while receiving the applications for new/existing ITIs seeking affiliation/QCI accreditation, the relevant document(s) in support of building permission as per building by laws of local planning authority, must also be insisted along with various other documents demanded for Desktop Assessment (DA). These documents are to be uploaded in the DA stage under 'Details of Land & Building of The Institute'.

In view of above, you are requested to issue directions for all the new cases & cases currently in the pipeline for August 2016 session (upto accreditation stage & those pending for DGT meeting, at your level) to upload the same. Further, the assessors going for site assessment must also be given clear instructions to ensure compliance in this regard.

Sir

Kindly refer to the earlier communication (e mail attached) regarding the above subject for forwarding the accredited files to DGT. In continuation to the matter, the following criteria is to be followed now for accreditation of new ITIs:

- 1. The earlier criteria of unserved districts + LWE districts + National Average is relaxed.
- 2. Those ITIs, who are unable to produce Building Completion Certificate now have to furnish following documents:
  - a) The approved Building Plan duly signed by the competent authority.
  - b) An undertaking from ITI: "I will submit the Building Completion Certificate (BCC), within six months otherwise my ITI shall be debarred from new admission in the next session.

In view of above, it is informed that Building Completion Certificate, duly signed by the competent authority as informed earlier(Certificate Format attached), has to be furnished by ITI.

You are requested to carry out accreditation process for new ITIs accordingly, & submit the duly accredited cases to DGT for consideration of NCVT Sub-Committee.
