SHOW- CAUSE NOTICE FOR DE-AFFILIATION OF TRADES/UNITS.

Sir/ Madam,

Whereas, the **Writ petition no. 3697/2019** was filed by you for quashing of de-affiliation orders dated 13th September, 2018 and 18th March, 2019, passed by the this Directorate General.

2. Whereas, in compliance with the interim order dated 08.05.2019 passed by the Hon'ble Delhi High Court, an inspection was carried out by the Joint inspection team on 31.05.2019 which adverts to various deficiencies (**copy enclosed**) as mentioned below:-

(a) Electrician and Health Sanitary Inspector (HIS) workshop set up in one hall without any partition. (b) Administrative and supporting staff not appointed. (c) Only 27 trainees present against sanctioned 126 seats at the time of inspection. (d) Store, staff room and office not available in institute. (e) Existing classroom furniture like table is not suitable for engineering drawing. (f) There is no separate classroom for ED and WCS. (g) Electrical connection not in name of institute. (h) Any license software not uploaded in IT lab computers. (i) IT lab instructor not present at the time of inspection. (j) Institute running in third floor of Gopal Plaza Complex. (k) All model made from thermocol in HIS trade. (l) No admission in HIS trade.
2.	Health Sanitary Inspector (HSI)	i) Shortage in Equipments like LCD Projector, overhead projector, Auto clave, thermometer, stethoscope and Hemoglobin meter etc. ii) Instructor not appointed.	

3. In view of above and also in compliance of the judgment dated 27.08.2019 passed by the Hon'ble High Court of Delhi you are requested to clarify why the de-affiliation orders dated 13th September, 2018 and 18th March, 2019 should not be acted upon. The reply must reach this office **within a week** of receipt of this show cause notice.

This notice does not invalidate any other previous notice(s) served upon you.
