Sir/Madam,

This is in reference to this office letter no. **MSDE-19/3/2015-CD** dated **5th August, 2015** in respect of the subject cited above (Copy enclosed). In this regard, the trades "**Driver Cum Mechanic**" (duration six months) and "**Mechanic Repair & Maintenance of Light Vehicle**" (duration one year) are allowed to be continued for another one year i.e. for year 2015. However, other trades of six months have been transferred under MES.

In view of above, it is informed that the NCVT MIS Portal will allow registration only for the trades "Driver Cum Mechanic" and "Mechanic Repair & Maintenance of Light Vehicle" for session August, 2015 in Govt. & Pvt. NCVT affiliated ITIs and other trades will discontinued accordingly.

Subject: Continuation of six months courses under Craftsmen Training Scheme having high market demand

Sir/Madam


This is to inform that the Sub-committee of NCVT on Norms and Courses, during its meeting held on 17th July, 2015, discussed the issue of Continuation of six months courses under Craftsmen Training Scheme having high market demand.

Sub-committee decided that only those courses which have more than 2000 affiliated trade/units at All India level would be continued for another one year. Rest would be transferred under MES. ITIs could be registered as VTP; infrastructure created could be utilized accordingly.

Accordingly, the only trade "**Driver cum Mechanic**" having more than 2000 affiliated seats, have been allowed to be continued for another one year i.e. for year 2015. Also, one trade namely "**Mechanic Repair & Maintenance of Light Vehicle**" of one year duration has also been approved to be continued for another one year.

In view of above, admission in above two trades are permitted for the admission session starting from August,2015 in Govt. and Pvt. NCVT affiliated ITIs.
