**Principles of natural justice includes:**

(a) **Rule against bias, Bias may include:**

- (i) Personal Bias;
- (ii) Pecuniary Bias;
- (iii) Subject matter Bias;
- (iv) Departmental Bias;
- (v) Preconceived notion basis.

(b) **Rule of *audi alteram Partem*** : this right to fair hearing includes:

- (i) Right to know adverse evidence;
- (ii) Right to present case;
- (iii) Right to rebut evidence;
- (iv) Right to cross examination and make legal representation
- (v) Right to get reasoned decision etc.

6. In view of the above facts and in view of the COVID situation in the State, inspection may be conducted after three weeks i.e., approximately in the month of June ending. The respondents shall fix up a date well in advance and intimate the date of inspection to the petitioners by giving a notice to them at least one week prior to the inspection date.

7. With these observations, the writ petition is disposed of  
No order as to costs.

Miscellaneous petitions, if any, pending shall also stand closed.
