The appellate committee constituted by Ministry Of Skill Development & Entrepreneurship vide notification DGT-HC044/456/2017-O/o DD(TC) Dt. 04.01.2018 to deal with all Grievances of ITIs whether emanating from the NCVT decision or on account of QCI inspection, had held a public hearing for 165 appellants during the period from 28.05.2018 to 31.05.2018.

2. The committee concluded ITIs under the category A3 to be fit case for granting affiliation, with an undertaking to the effect that they shall create infrastructure for second trade within six months failing which affiliation shall be withdrawn & accorded approval for these cases.

Accordingly the case of Sunrise Private ITI, is found a fit case for granting affiliation, as they have submitted BCC and above undertaking.
