The Standing Committee Inspection Report (SCIR) of Balaji Pvt. ITI Kothagudem, forwarded to DGT, were put up before the member of the Sub-Committee of National Council for Vocational Training (NCVT) dealing with affiliation of ITI/ITCs in its meeting held 11.12.2018 at DGT, MSDE New Delhi for its consideration and approval.

2. The Sub-Committee examined affiliated proposals and accorded approval to the proposal conforming to the NCVT Norms, as per the list enclosed herewith. However, the decision of the committee was not published due to the interim order of stay 12.09.2018 passed by the hon'ble H/C in W.A No. 730/2017.
3. As of now, the W.A 730/2017 has been dismissed as withdrawn vide judgement dt. 04.03.2020 passed by the hon'ble H/C of Hyderabad. Hence, the decision of the sub-Committee is here by published with the approval of the competent authority

 - The ITI must comply with NCVT norms/guidelines issued from time to time.
 - ITI must display the newly released logo of ITI on the Display Board at the main gate.
