**Subject:- Extension of dates for generation of Hall Tickets for AITT under CTS (Semester System / Annual System) to be held in April, 2020 - Regarding.**

Sir/Madam,

With reference to this office letter of even no. dated 28.02.2020 on subject matter, it is reported by some State Directorates/ITIs that still there is some pendency for uploading hall ticket eligibility criteria on NCVT portal and generation of hall tickets. In order to avoid any inconvenience to the trainees, the dates for completing hall ticket eligibility criteria and generation of hall tickets is extended as per the following schedule, so that all trainees of concerned ITIs may appear in AITT April, 2020 with NCVT MIS Portal generated hall tickets.

(b) Upload of Formative Assessment marks, Attendance and exam fee for supplementary exam (all ex-trainees of Year-I) in annual system of exam.	24.03.2020 to 27.03.2020	By Principal of ITI
2.	Upload of centre mapping and generation of Hall Tickets through NCVT MIS Portal for semester system & annual system.	28.03.2020 to 30.03.2020	By State/UT Directorate.
3.	Downloading of Hall Ticket from NCVT MIS Portal and issue to eligible trainees for semester system & annual system.	31.03.2020 to 08.04.2020	By Principal of ITI.

**NOTE:- This is Final Chance and Extension of above mentioned dates may not be possible due to start of examination on 08.04.2020.**

In view of above, you are requested to strictly follow the specified dates and ensure entry of hall ticket eligibility criteria i.e. Sessional marks / Formative Assessment marks, Examination Fees and Attendance of trainees by the concerned ITIs under your control, so that hall ticket generated from NCVT MIS Portal can be provided to all the eligible trainees to appear in AITT under CTS (Semester System/Annual System) to be held in April, 2019. Candidates without NCVT MIS portal generated Hall Ticket should not be allowed to appear in exam.
