Sir,

In partial modification to DGT letter dated 22.10.2020 and with reference to the letter no. 162/टी-3/रा.प./सं/ DGT-60/2019 dt. 18 .02.2020 from the Director, State Director, Department of Employment and Training, Guru Gobind Singh Marg, Lucknow, Uttar Pradesh – 226004 which has forwarded the proposals on the subject cited above. It is to inform that the Trades/Units of 03 Private ITIs (as per the list enclosed) affiliated to DGT have been de-affiliated. Directorate General of Training gave opportunity to all the ITIs represent through Show-cause notice intimating the deficiencies reported. Replies received were examined and Joint Inspection of the ITIs were carried out and placed before the 10th Recommendation Committee Meeting-DGT dt. 15.10.2020 at agenda item no 10.2.

As decided by the committee, the ITIs, as per annexure, are De-affiliated from the Session 2020, and will not be allowed to take admissions in Session 2020. However, the students already undergoing training will continue their training and it is the responsibility of concerned ITI to provide complete training as per curriculum and schedule. The De-affiliated ITIs are de-barred for a period of 3 years (till 2022 as per norms); after 3 years ITIs can apply for Re-affiliation, if they desire as per the terms & conditions of affiliation prevailing at that time. The status of these de-affiliated ITIs will be reflected as "Active/Affiliated" to facilitate earlier batch student to upload attendance, download Hall Tickets etc., and trades will be "de- activated" on NCVT MIS Portal so that ITIs shall not take admissions.

The said information is also available on web site https://ncvtmis.gov.in . In case of any discrepancy observed in the de-affiliation orders, same may be intimated to undersigned within a week of date of receipt of the order.
