Approved MINUTES OF THE 10TH MEETING OF "RECOMMENDATION COMMITTEE DGT" DEALING WITH AFFILIATIONS OF ITIS, HELD ON 15th SEPTEMBER, 2020 AT 15:00 HRS THROUGH VIDEO CONFERENCE.

At the outset, Sunil kumar Gupta, Director and Shri Ravi Chillukoti, JDT welcomed all the committee members and thereafter the DG took agenda points for detailed discussions. The details of discussions, deliberations & agenda wise decisions taken by the chair, are placed as below:

Agenda No. 1:

CONFIRMATION OF THE MINUTES OF THE 9TH MEETING OF THE "RECOMMENDATION COMMITTEE DGT" DEALING WITH AFFILIATION HELD ON 9TH OCTOBER 2019.

- a. The members of the Recommendation Committee were informed regarding the approved minutes of the meeting which was held on 09.10.2019 (placed at <u>Appendix-1</u>). `and since minutes were not circulated. These minutes of 9th meeting will be open for receipt of comments, after 7 days MoM will be finalised and issued.
- **b.** The action taken report regarding the Recommendation Committee DGT meeting dated **09.10.2019** was presented vide **Appendix-II** before the Recommendation Committee Members for their information.

Agenda No. 2:

Affiliation of ITI's which are jointly inspected

Committee was informed that DGT introduces online affiliation portal i.e. "www.nimionlineadmission.in/iti" on 15.12.202019. Generation of "Standing Committee" for inspection of ITI is to be done by the portal through 'Auto generation mode in order to avoid any human intervention & to make the system more transparent from August, 2020.

Further, It is informed that some of the ITIs applications which were registered on TCS portal and submitted through one-page format on www.ncvtmis.gov.in were inspected early before the introduction of "Auto generation" of Team were considered and placed in a meeting. However, now all the applications were moved to the NIMI portal and inspection team is to be made through Auto generation Mode. All the Sates who have not submitted the details of officers for auto generation of team are requested to submit the details as early as possible in order to finish the job at the earliest and make the process transparent and smooth. Inspection reports of the below mention ITIs are received at DGT for grant of Affiliation for extension of Trades/Units/shifting from their respective State as per details given below; same were scrutinised and consolidated sheet was displayed to the members for discussion: -

Committee took all the aforesaid matters one by one and after detail discussion expressed its recommendations as follows: -

- i. That, the proposals for affiliation were approved / rejected by the committee, as per remarks mentioned against each column of ITIs (list enclosed).
- ii. That, single unit per shift shall not be allowed for two years' Trade/courses but at least two units per shift may be considered for approval. Whereas, for one year's Trade/Courses no such limitation would apply. Accordingly, the instant proposals of affiliation considered and it was recommended to grant provisional affiliation to such ITIs who applied for single unit per shift for two years' courses, such ITI shall apply and seek affiliation for another unit for next session so that fresh admissions may be taken by ITI every year.
- iii. That, the respective State Directorates may offer their comments on time slots that are being / supposed to be given for running 3rd shift in ITIs. On receipt of the comments same would be reviewed and until then, affiliation for 3rd shift i.r.o. instant proposals shall not be granted as there would be requirement of two separate workshops for such arrangements i.e. for 3rd shift.
- iv. That, as per affiliation norms ITI(s) should have minimum 4 trades; accordingly, the proposals for affiliation which do not fulfilling these criteria were rejected.
- v. That, the case(s) where ITI(s) was not ready for inspection, were rejected and such ITIs may be advised to apply afresh, for seeking affiliation.
- vi. That, Standing Committee for inspection may be advised that while forwarding inspection reports it shall also mention (i) the scope of job opportunities in that relevant trade(s) in the respective State, and (ii) status report of affiliated Trade(s)/unit(s) already running in that particular block/district and status of seats per block. Provision to that effect should be made in IT tool.
- vii. That, the instant proposals i.r.o. existing/old ITI(s) may be put up in ensuing meeting with detailed statement indicating (i) nos. of affiliated trades, (ii) Trainees admission trends in particular ITI, (iii) results of trainees and; (iv) ITI's rank etc.

Agenda No 3:

CONSIDERATION OF PROPOSALS FORWARDED BY STATE DIRECTORATE REGARDING UP-GRADATION OF TRADES AFFILIATED UNDER SCVT TO NCVT.

The 151 nos. of proposals from 05 States were received for up-gradation of trade earlier running under SCVT into NCVT. Agenda No 4:

CONVERSION FROM COE TO CTS

10 Proposals received from Tamil Nadu State regarding conversion from CoE to CTS trades in Govt ITIs. Reports were scrutinised by DGT as per affiliation norms. It was informed that out of 10 ITIs, only one ITI is complying with all requirements and in remaining 9 ITIs, Electricity load is short, hence proposed with less

units (as per the statement). However, Chairman advised to put the aforesaid proposals in ensuing meeting with detailed statement indicating (i) nos. of affiliated trades, (ii) Trainees admission trends in particular ITI, (iii) results of trainees and; (iv) ITI's rank etc. (v) division of private and governments.

Agenda No 5:

SHIFTING PROPOSALS IN KARNATAKA

State Directorate of Karnataka has forwarded the proposal with recommendation for shifting of 13 Private ITIs inspected by State Government officers (Assistant Director and Govt ITI Principal) referring to the DGT letter no. DGT-11014/5/2018-O/o Dir (Trg) dt. 04.06.2018. These ITIs were inspected in 2018 and report submitted in May 2020 (which is prior to changes in shifting rules by DGT i.e on 18.09.2020). The proposal was placed before the committee.

Since the reports were outdated the same were rejected by the committee with an advice for ITIs to apply afresh on NIMI Portal for this NIMI should allow application for this session itself. Committee further recommended that in the mean time no admission should be allowed.

Agenda No 6:

CHANGE OF NAME PROPOSED BY ST. JOSEPHS TECHNICAL SCHOOL PVT ITI.

St. Josephs Technical School Pvt ITI, Mumbai (PR27000039), submitted application for change of name from "St. Josephs Technical School Pvt ITI" to "Don Bosco Industrial Training Institute". It is informed that there is no change in location. Copy of resolution was placed before the committee. As change of name of ITI is permissible as per Category 3 of Affiliation Norms 2018, so committee approved the same.

Agenda No 7:

STARTING OF NEW AGE COURSES IN ITIS

It was informed that DGT issued letter dt. 12.06.2020 to all Additional Chief Secretaries, for promoting New age courses. Already 49 ITIs (list attached) already registered from 14 states. All the above States were advised to process these applications on top priority.

It was further informed that Tamil Nadu and Odisha State Government wants to start new age courses in Govt ITIs from Session 2020, but they had not applied on online affiliation portal.

The committee recommended to open the NIMI portal for one week for such Govt. ITI as a special case to complete all the formalities and apply on NIMI Portal for New Age Courses only, for session 2020.

Agenda No 8:

8.1 INSPECTION REPORT SUBMITTED BY S.R. MAHANA PRIVATE ITI, RAJASTHAN

It was informed that S R Mahana Pvt ITI was inspected on 30.09.2019 and Standing committee had recommended for Electrician 6(2+2+2), whereas report received on 28.07.2020 through ITI only. Since the report was outdated the same was rejected by the committee with an advice for ITI to apply afresh on NIMI Portal. As a special case NIMI portal will be opened for this ITI only to apply and complete the process within 15 days. Accordingly, inspection shall be carried out.

8.2. CLARIFICATION BY BHIMSHANKAR PANDEY MEMORIAL PVT ITI, UTTAR PRADESH:

It was informed that the ITI was not recommended by 9th Recommendation Committee Meeting held on 9.10.2019 (agenda item 9.5.6), as the ITI was not having a qualified Principal as per DGT norms. The committee rejected the same. However, the ITI again submitted the details of principals in January 2020. The same was put to committee and the committee expressed that since the ITI has already rejected and there is no pendency, ITI shall apply afresh on NIMI portal for seeking affiliation from next session.

Agenda No 9:

COURT CASES

9.1 VERIFICATION OF ITIS SEEKING MORE THAN 8 UNITS IN ONE SHIFT

It was informed that as decided in the 6th Recommendation Committee meeting held on 31.07.2019 (6.03), any ITI which is running more than 8 units in any one shift will be taken up for re-inspection by team having a Director level officer from DGT and JD level officer from State. Seven such ITIs were inspected in Bihar.

As recommended in 7th Recommendation Committee Meeting held on 27.08.2019 (agenda 7.07), affiliation letter as recommended issued for the units recommended by the committee. However, the following three ITIs viz. Kumar Pvt ITI, Maa Sharada Pvt ITI and Rajdeo Yadav Pvt ITI filed WP (9672, 9675 and 9674) in Hon'ble High Court at New Delhi challenging the DGT orders: -

Hon'ble court had disposed off the matters with direction that department may consider the pleas and decision may be taken accordingly. DGT intimated in writing, the deficiencies observed during inspection. ITIs submitted compliance report against deficiencies noticed during inspection.

As per court directions, matter of ITI at sl no.3 was to be decided before 12th September,2020. Accordingly DGT requested Bihar State Directorate vide letter dt. 02.09.2020 to nominate State representative for verification and reminded on 07.09.2020 through e-mail. However still no response received from State Directorate.

Chairman asked RDSDE-Bihar to expedite the inspection on top priority.

9.2 SUNRISE PVT ITI, RAJASTHAN (PU08001497) (WP 1140/2020)

As per court directions joint inspection was carried out and Standing committee had not recommended due to various deficiencies and they have recommended for De-affiliation. The 'Recommendation Committee DGT' approved the same and further recommended not to allow their admissions and to initiate de-affiliation process against the concerned ITI.

9.3 Bonagarh ITC Bonagarh, Dist. Sundergarh, Odisha

As per court directions joint inspection was carried out and committee not recommended citing various deficiencies and proposed for de-affiliation. Committee recommended for De-affiliation.

Agenda No. 10:

DE-AFFILIATION OF ITIS

10.1 DE-AFFILIATION OF ITIS IN UTTAR PRADESH:

It was informed to the committee that Letter no. 2733/T-3/RP/S/De-affiliation/2018 dated 03.10.2018 was received from the Director Training & Employment, Lucknow, Uttar Pradesh addressed to DG (T) regarding de-affiliation of 115 ITIs in the State of Uttar Pradesh. Subsequently, DGT had issued show cause notices to 115 ITIs seeking reply from them. The replies of 108 ITIs were not found satisfactory & justified. The matter of de-affiliation of these ITIs was placed before the 2 nd Recommendation Committee Meeting held on 28.03.2019 at agenda point No.2.4. The committee recommended for de-affiliation of these ITIs, but before issue of De-affiliation order, it was challenged by 94 ITIs in Honorable Courts of Law. The matter was then reviewed in 4 th Recommendation Committee Meeting held on 28.05.2019. It was decided that the said ITIs will be taken up for joint inspection and decision will be taken based on the Inspection report of these ITIs.

Further, In addition to 108 ITIs, 19 more ITIs were included for Joint Inspection for De-affiliation based on the complaints received against them, State Directorate forwarded the reports along with remarks of recommended for de-affiliation. (list enclosed).

Committee approved the recommendations as given by the Standing Committee as per remarks mentioned against each column of ITIs (list enclosed) and De-affiliation of these ITIs from the Session, 2020.

10.2 DE-AFFILIATION OF ITI IN HIMACHAL PRADESH:

It was informed that Dimond Pvt ITI, Himachal Pradesh whose lease deed expired in 2018, was running without renewal of lease. Report was also forwarded by State after necessary verification. As the ITI has not produced renewed lease document and is functioning without valid lease which is in violation of DGT norms, so accordingly ITI was proposed for De-affiliation.

The committee approved the same and further advised the DGT to make such provision mandatory to capture data pertaining to validity of lease documents of ITIs so that such case can be identified.

10.3 DE-AFFILIATION OF 2 ITIS IN MADHYA PRADESH:

IT was informed that two nos. of ITIs namely Pushpa Pvt ITI (PU23000999) and Parvathi Pvt ITI (PR23000634) were recommended by State Directorate for De-affiliation and accordingly, Joint inspection was carried out. The reports were forwarded by the state directorate recommending for De-affiliation of both of these ITIs. The same was put to committee for De-affiliation. Committee approved the same for de-affiliation.

10.4 DE-AFFILIATION OF ITI IN RAJASTHAN:

It was informed that State Director proposed for De-affiliation of 154 ITIs for which show-cause notices were issued as per De-affiliation procedures. To avoid legal complications, it was proposed to carry out Joint inspections to verify the statements given in reply to show-cause notice.

The Committee recommended to de-affiliate the aforementioned 37 and 64, ITIs from the Session 2020, where the show cause notices (SCN) returned and reply to SCN were not received from them. Further, if no admission in this year to be deactivate. For rest of 53 cases, committee asked to put up the same in ensuing meeting with detailed note with DGT's recommendations. However, the Committee recommended to de-affiliate the aforementioned 04 ITIs (SCN of 2 ITIs returned and 02 ITIs not replied), from Session 2020 where Show cause notices (SCN) returned and reply to SCN had not received. For rest of 17 cases, committee asked to put up the same in ensuing meeting with detailed note with DGT's recommendations. The De-affiliated ITI shall not be allowed to take admission by State Government & if not allowed 2019, deactivation to be done.

Agenda No 11:

DE-AFFILIATION PROPOSAL AGAINST COMPLAINTS

11.1 Complaint against Seven Hills Pvt ITI, Andhra Pradesh: Complaint received from general public with photos as evidence against the Seven Hills Pvt ITI stating that many institutes were functioning in the same premises. DGT issued letter dt. 14.05.2020 for "Standing Committee Inspection" to verify the facts. ITI approached Hon'ble high court, Andhra Pradesh, Hon'ble court has given directions to inspect ITI after three weeks, giving one week notice to ITI. Accordingly, DGT issued another letter dt. 19.06.2020 for inspection on 29.06.2020. Inspection report was forwarded by State Directorate and recommending the ITI for Deaffiliation. Again, ITI filed case in Hon'ble high court, which is due for listing, but three is no stay on Deaffiliation action by department.

The committee considered the proposal and recommended to de-affiliate the ITI. from Session 2020 and this ITI shall not be allowed to take admission by State Government. And for 2019, if de-activated on portal, should be activated.

- 11.2 It was informed that the following three ITIs of Uttar Pradesh forged the signature of DGT Officers: -
 - 1. Sri Ramchandra Pvt ITI (PR09900619)
 - 2. Kaushailya Devi Smarak Pvt ITI (PR09001830)
 - 3. Tribhuvan Pvt ITI (PR09001041)

These ITIs were jointly inspected, and found that many deficiencies observed. Accordingly, the committee recommended to de-affiliate these ITIs. These ITIs shall not be allowed to take admission by State Government. Further, criminal action should be taken against these ITIs.
