This office received a Joint Inspection Committee Report vide forwarding letter no. 3398/टी -
3/टीओ/सो/De-Aff/2020 लखनऊ दिनांक 03.12.2019 from the Director, Training & Employment, Uttar
Pradesh, Lucknow, they have found following Irregularities (copy attached): -

1. Institute not found at the address given in the affiliation order DGET-6/24/125/2011- TC, dated 18.08.2011. (Sri Raghav Private ITI, 406, Baddhar Chowraha, Hathras road, Sadabad, Hathras, U.P. It is observed that the institute shifted to Mendu, sikandrau rao road, Hathras (out of block Sadabad) without intimation to concerned authorities.
2. BCC is issued in 2017 and is not according to affiliation order uploaded. BCC issued by SDM Hathras instead of SDM, Sadabad.
3. Electrical supply cable is laid underground and is not visible. Meter ceiling report dated 01.08.2019 in not according to affiliation order dated 18.08.2011.
4. No endorsement of stock register details on the bills.
5. Original certificates of qualification and experience not shown. None CITS qualified instructor available. Only four staff (with out id card) present at the time of inspection.

Therefore, you are directed to clarify on this subject, why not initiate action for de-affiliation of your institution.
