

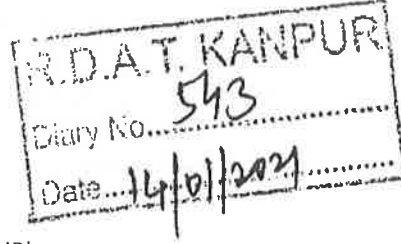

Subject: Inspection Report of TNPS, ITI, Agra (UP)

Sir,

With reference to Office Order No. RDK/ITI Inspection/2020-21/Part2 dated 08.01.2021 of RDSDE (UP) – Kanpur regarding examination of complaint raised in letter received from DGT (HQ), New Delhi against TNPS, ITI, Agra, UP (PR09000394), my observations are mentioned below.

1. As per NCVT MIS portal this institute has affiliation of Electrician (2+2 units) & Fitter (1+1 units) trades in year 2012. The Principal name mentioned in MIS portal is Mr. Ripu Daman Vats, while inspection Mr. Y.P. Singh met me at this institute & told that he is the principal of this institute & informed that they have applied for Electrician (2+2 units) & Fitter (1+1 units) additional trades & recently DGT Joint inspection team has inspected their institute but affiliation of additional trades is awaited.
2. During inspection, no trainees were found in this institute & no additional documents related to training produced by this ITI to check the quality of training.
3. Electricity Bill/ load copy of May 2020 & June 2020 of 9.0 KW load & November 2020 of 18.0 KW load copy is attached as annexure A from page A-1 to page A-8.
4. Attendance registers of staff not shown by this ITI. Principal of this ITI told that attendance is monitored by biometric machine but no related documents shown by them.
5. Regarding payment of staff, ITI principal told that payment to staff is done by cheque & cash but no supportive documents submitted/shown by them.
6. All major tools & equipments were available of Electrician & fitter trade (Bill Copy attached as annexure B from page B-1 to B-21). Insulation rubber mats were not found in Electrician workshop.
7. TNPS intermediate college was found in adjacent building. This College & TNPS ITI are separated by boundary wall with 3 gates common (2 gates of them were found locked. Third small gate was found open for common guarding purpose as stated by ITI Principal.
