
SHOW CAUSE NOTICE REMINDER FOR DE-AFFILIATION OF TRADES/UNITS/ITI

SHOW CAUSE NOTICE FOR DE-AFFILIATION OF TRADES/UNITS/ITI


Sir/Madam,

This office received a Joint Inspection Committee Report vide forwarding letter no. 3398/डी - 3/रा०प०/सं०/De-Aff/2020 लखनऊ दिनांक 03.12.2019 from the Director, Training & Employment, Uttar Pradesh, Lucknow, they have found following Irregularities: -

1. Lease Document of Institute not found at the address given. Lease document dated 04.11.2019 is not registered and not according to affiliation order as uploaded. Rent paid transaction so far not shown.
2. Original BCC not produced.
3. No physical power connection found, Mounted power meter number -UP-034438 is not matching with the bill dated 16.11.2019.
4. original documents of staff appointments, qualifications and experience are not available.
5. Lathe machines, grinding machines and drilling machines are not installed with proper foundation, and not in working condition.
6. Institute not found at the address given, it is observed that the institute shifted to Kasganj road, sikandrau rao, Hathras (out of block Mursan) without affiliation to concerned authorities.
7. Toilets are not in good condition, library furniture not available and no evidence of regular functioning of library. NIMI books are not available purified drinking water facility is not available


Therefore, you are directed to clarify on this subject, why not initiate action for de-affiliation of your institution.
