As you are aware that a Sectoral Trade Course Committee (STCC) for 40 sectors had been constituted on dated 09th April, 2020 to work on different sectors of economy to revitalize the large networks of ITIs and NSTIs under DGT as well as to standardize the processes of training, assessment and certification system of a particular sector area.
