Sir/Madam,


This is with reference to the letter from the State Directorate Punjab vide letter no. IT/Affi/NCVT/QCI-15/Lord Shiva Lehri/Bathinda/7560 dated 24/07/2017. in which it is stated that your ITI inspected on dated 01.06.2017 and 12.06.2017 (copy attached) and during the inspection following deficiency found in your ITI: -

1. **Class-IV staff was available at institute.**
2. **There was no machinery of relative trades.**
3. **Lack of sources / infrastructure are noticed at institute.**
4. **ITI is not providing training as per NCVT Norms.**

You are therefore, requested to clarify why action should not be initiated to de-affiliate your institute.

- **Your reply must reach this office within 15 days i.e. by 21.07.2021 positively.**

Subject: - Regarding the de-affiliation of Lord Shiva Private ITI, V.P.O Lehri, Distt, Bathinda.

It is intimated that joint inspection of Lord Shiva Private ITI, V.P.O Lehri, Distt, Bathinda was carried out by Joint inspection Committee as per directions issued by DGT, Govt. of India vide letter no. DGT-20/21/2016/TC dated: 27.01.17

The Committee in its report has informed this office that aforesaid ITI was visited on 01.06.17 and 12.06.17 but only a Class-IV staff was available at institute. It was also observed by Committee that there was no machinery of relative trades at institute and institute premises is being used for some another purpose.

As serious deficiencies and lack of sources/infrastructure are noticed at institute. It shows ITI is not providing training as per NCVT norms. Therefore, the recommendations to de-affiliate Electrician-4, Plumber-2 trade/units of aforesaid ITI are hereby forwarded to DGT Govt. of India along with joint Inspection Committee report.

Therefore, You are requested to de-affiliate above mentioned trades of above said Pvt. ITI with immediate effect.
