**Subject: Standing Committee on Accreditation and Affiliation's decision on Proposals of ITIs involved in producing Fake Bank Guarantee in Uttar Pradesh**

Sir

This is in reference to 3<sup>rd</sup> Meeting of "Standing Committee on Accreditation and Affiliation" held on 07.09.2021 and Minutes of meeting of the same issued vide "DGT-11012/5/2021" dt. 13.09.2021.


Vide agenda item no. 3.8, the summary of the decision of the committee is as:

1(a)	For 40 New ITIs, affiliated in session 2019 and 2020, and produced Fake BG, they should not be allowed admissions from 2021 session in the units affiliated in 2019 and 2020.	The Committee agreed with the proposal of the Uttar Pradesh State Directorate	Committee approved for De-affiliation of these 40 ITIs and debarred them for 3 years. No further admissions to be allowed to these ITIs from session 2021.  However, it is the responsibility of the ITI to ensure that the training of the Trainees enrolled in previous sessions is Complete.
1(b)	For 21 Existing ITIs, affiliated in session 2019 and 2020, and produced Fake BG, they should not be allowed admissions from 2021 session in the units affiliated in 2019 and 2020		For these ITIs, the Trades which got Affiliated during session 2019 and 2020, on submission of Fake Bank Guarantee shall be de-affiliated. However, the ITIs are allowed to take admissions in previously affiliated units from session 2021.
2	657 new applications which had used Fake BG shall not be considered further for Accreditation/ Affiliation		These applications produced Fake Bank Guarantee, thus they will be rejected from NIMI portal. To be debarred from applying on Online Affiliation Portal for 3 years.

3	For 160 Existing ITIs, applied and produced Fake BG, they should not be allowed affiliation in additional units/ trades for which they applied. No action maybe carried on existing units of these ITIs		As these ITIs did not get affiliation in the units for which they produced Fake BG. committee approved for allowing these 160 ITIs to take admissions in existing Trades/ units from session 2021.
4	New and Existing ITIs for which BG was found okay, maybe processed further for accreditation and affiliation		Agreed
5	The provision of BG as decided by State, may also be included in Affiliation norms for UP ITIs		It was suggested that the State Directorate may take these norms as part of their NoC format.

Henceforth, the above recommendations/ approval shall be implemented with immediate effect.
