**Subject:** Activities in ITIs during "Har Ghar Tiranga" Programme

3. Awareness about our National Flag through nukkad natak and jingles in local languages
4. Wall Paintings/Posters with high footfalls

Speech by trainees may be for the duration 10 to 15 minute on each topic. The following schedule for organizing event region wise:

12.08.2022-13.08.2022	ITIs in State located in Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Tripura and Sikkim.
14.08.2022-15.08.2022	ITIs in state located in Dadra and Nagar Haveli, Daman & Diu Goa Gujarat, Karnataka, Maharashtra, Rajasthan, Haryana, Kerala Madhya Pradesh, Punjab, Uttar Pradesh
16.08.2022-17.08.2022	ITIs in state located in Andhra Pradesh, Telangana, Karnataka, Kerala, Tamil Nadu, Andaman, Lakshadweep Island
