You may kindly the aware that the accredited proposals received from QCI are scrutinized at this directorate with reference to the available data on the QCI Portal before these are submitted to sub-committee of NCVT for affiliation. Similarly, the scrutiny is also done for the cases where corrigendum are to be issued and reference is required to be made in VIP cases etc.

Nearly for past one month, the QCI Portal is not working / is closed. As such we are unable to access to the data to scrutinize the proposals related to issue of corrigendum. There are about 40 cases where corrigendum requires to be issued immediately so that trainees of these institute could be allowed to write the examination which have since been commence & from 2nd Feb, 2017. Further as no data of the ITI's is migrated to NCVT MIS Portal, the matter remains unresolved besides the application lying at stage 3c/5Aat QCI are also awaited.

The matter was discussed in review meeting held on 24.01.2016 wherein QCI assured to make the portal operational but nothing so far has been done. The portal is still closed which is adversely affecting the working at DGT.

You are requested to kindly open the postal immediately and also sent the proposals as have been requested vide has directorate letter of even no dated 29.12.2016 (Cogy enclosed)
