**Office Memorandum**

**Subject: Compliance of judgment dated 03.08.2022 passed by the Hon'ble High Court of Himachal Pradesh at Shimla in CWP No. 3946/2022 titled Galaxy Private Industrial Training Institute Versus Union of India & Ors. - Regarding**

1. Whereas, the petitioner institute [**Galaxy Private ITI (PR02000177)**] filed the writ petition for seeking to quash order dated 15.06.2022 through which the Petitioner ITI has been de-affiliated on the grounds of violation of the Affiliation Norms-2018 as the Petitioner ITI had shifted its location without the prior approval of the competent authority.
2. Whereas, the Hon'ble Court vide its interim order dated 19.07.2022 has inter alia directed that the Joint Inspection Committee shall first inspect the petitioner-institute and submit its report and only thereafter this court would proceed to chalk out further course of action.
3. Whereas, the Hon'ble High Court vide its judgment dated 03.08.2022 has given directions that-
  - 1) *... it will be unduly harsh to disaffiliate the petitioner's institute as was otherwise ordered vide the impugned order dated 15.06.2022. Rather, we are of the considered view that since the petitioner's institute has not been found to be wanting in any manner and rather has been found to be complying with respect to manpower as also infrastructure, ends of justice would be served if the monetary penalty is imposed upon the petitioner.*
  - 2) *In the given facts and circumstances of the case, we deem it appropriate to impose penalty of Rs.2,00,000/- upon the petitioner, which shall be paid to respondent No.2 within a period of one week from today. In the event of deposit of such penalty, the petitioner shall be permitted to continue running the institute within the parameters of law.*
  - 3) *Before parting, it is made clear that this order is being passed in the peculiar facts and circumstances of the instant case and it shall not be treated as precedent in future.*
  - 4) *Consequently, the impugned order dated 15.06.2022 is quashed and set aside. The respondents are directed to rectify the website by including name*

*of the petitioner's institute amongst the recognized Institutes, that of course, shall be only after the deposit of the penalty amount..."*

4. That as per the Hon'ble High Court, Himachal Pradesh, Shimla order dated 03.08.2022, the impugned order dated 15.06.2022 and subsequent corrigendum issued dated 04.07.2022 i.r.o de-affiliation of Galaxy Pvt ITI(MIS Code-PR02000177) is being revoked and its trades/units has been activated in the NCVT-MIS Portal.
5. Therefore, in terms of aforesaid decision of the competent authority at DGT, the judgment dated 03.08.2022 passed in CWP No. 3946/2022 by the Hon'ble High Court of Himachal Pradesh at Shimla stands complied with in all respect and no course of action is pending on behalf of the answering respondent in this regard.

This issues with the approval of competent authority.
