Sir / Madam,

With reference to show cause notice was issued by DGT vide. dt.23-06-2020, no reply has been received from the said ITI. Since reply is not received from the ITI, competent authority has decided to conduct joint inspection through DET & RDSDE, Bihar. Accordingly, joint inspection was carried out and recommended for de-affiliation of Modal Private ITI by DET, Bihar vide. Letter No.3438, dt.25-08-2021. Hence, competent authority has decided issue de-affiliation order to Modal Private ITI, (PR10000457) Patna, Bihar Ram Nagar, Road No. 04, Postal Park, Kankarbagh, Patna- 800001.

In this regard, it is to inform that the trades/units affiliated to this ITI Electrician - 2 (1+1), Fitter - 2 (1+1), have been de-affiliated with immediate effect as per approval of competent authority. The details are given in below mentioned table-


