With reference to the show cause notice issued by DGT vide. dt.23-06-2020, no reply has been received from the said ITI. Since reply is not received from the ITI, competent authority has decided to conduct joint inspection through DET & RDSDE, Bihar. Accordingly joint inspection where carried out and recommended for de-affiliation of Girja Private ITI by DET, Bihar. vide. Letter No.3438, dt.25-08-202. Hence, competent authority has decided to issue de-affiliation order to Girja Private ITI, (PR10000185) Patna, Bihar, Bailey Road, Patna – 800040.

In this regard, it is to inform that the trades/units affiliated to this ITI Electrician – 4 (2+2), Fitter – 4 (2+2) have been de-affiliated with immediate effect as per approval of competent authority. The details are given in below mentioned table-
