**Office Memorandum**

**Subject: Compliance of order dated 07.12.2022 passed by the Hon'ble High Court of Himachal Pradesh at Shimla in CWP No.8339 of 2022 a/w COPC no 422 of 2022 titled Takshila Private Industrial Training Institute Versus State of HP & Ors. - Regarding**

Whereas, the petitioner institute [**Takshila Private ITI (PR02000211)**] has filed the writ petition in WP 8339 of 2022 inter-alia challenging DGT OM dated 09.11.2022 to the extent that the petitioner ITI may be permitted to admit the students for session 2022 instead of session 2023.

2. Whereas, the Hon'ble High Court vide its order dated 07.12.2022 in connected matter of CWP No 8339/2022 a/w COPC 422/2022 has observed that the previous order dated 05.08.2022 passed in CWP 6360 of 2021 has not been complied with in letter and spirit. Accordingly, the Hon'ble Court has directed the respondents to resolve the issue by the next date of hearing, i.e., by 21.12.2022.

3. That, in compliance to the aforesaid order dated 07.12.2022, the matter is reconsidered by the DGT in discussion with concerned stake holders. And, accordingly as per the approval of competent authority DGT's order No. DGT-Aff011(18)/82/2019-O/o Dir(TC) dated 09.11.2022 (copy enclosed) is hereby amended to the extent that the approval is accorded to the ITI for the trades/units listed in Annexure-I for session 2022 instead of session 2023. Being as special case, the petitioner ITI is advised to share the data of admitted trainees for session-2022 to DGT by 21.12.2022, for necessary Upload and other NCVT Portal related activities to be carried out by either by DGT, SPIU-Himachal Pradesh or ITI at later possible schedules.

4. This Office memorandum shall not be treated as precedent. And it would be placed before the Standing Committee of Accreditation and Affiliation (SCAA) or equivalent body in its ensuing meeting, for information and its ratification.

This issues in compliance with the Hon'ble Court's directions dated 07.12.2022 and with the approval of the competent authorities.

**Office Memorandum**

**Subject: Compliance of judgment dated 05.08.2022 passed by the Hon'ble High Court of Himachal Pradesh at Shimla in CWP No. 6360/2021 titled Takshila Private Industrial Training Institute Versus State of HP & Ors. - Regarding**

Whereas, the petitioner institute [Takshila Private ITI (PR02000211)] is affiliated to NCVT for the trade of Electrician in 02(1+1+0) units, Additional 04 (1+1+2) units and Additional 3 (1+1+1) units thus **total-9(3+3+3)** units w.e.f. session Aug-2011, 2014 and 2019 respectively.

1. Whereas, petitioner ITI applied for seeking affiliation for additional units 4th base unit (i.e. for Additional 3-(1+1+1) units in the electrician trade for session-2020. That, on the ground of prevalent Covid conditions and in view of the various directions of the Hon'ble High Court Shimla, DGT finally decided the application of the petitioner vide its letter dated 26.08.2021 and granted affiliation for additional 2(1+1) units only w.e.f. session Aug-2021 and only for one year provided that ITI shall comply with 4 trades criteria before the start of session-2023.
2. Whereas, petitioner ITI has been provided affiliation for above additional units 4th base unit (i.e. for Additional 2-(1+1+0) units in the electrician trade w.e.f. session-2022 vide DGT letter dated 28.07.2022.
3. Whereas, the Hon'ble High Court vide its judgment dated 05.08.2022 has given directions that-
  1. *"...Since, the shortcomings as earlier pointed out in the petitioner-Institute, have been rectified and acknowledged by the officers present in person, let the provisional permission granted by this Court to the students of the petitioner-Institute to take examination of NCVT Certificate, be confirmed and regularized.*
  2. *It is further clarified that now that the petitioner has got permission of 5 years to run the institute, it shall be permitted to run the third shift also and the admission made for the third shift shall be deemed to be regularized...."*
4. That, in compliance of the Hon'ble High Court's judgment dated 05.08.2022, the trainees of the petitioner ITI would be allowed to take examination of NCVT Certificate.
5. That, further as the ITI was not affiliated to the 3rd shift, henceforth in compliance of 3rd shift matter, this may be granted under DST mode provided that ITI will have to sign an MoU with industry within one month from the issue of this memorandum and same may be recommended through SSDEC.
6. Therefore, in terms of aforesaid decision of the competent authority at DGT, the judgment dated 05.08.2022 passed in CWP No. 6360/2021 by the Hon'ble High Court of

Himachal Pradesh at Shimla stands complied with in all respect and no course of action is pending on behalf of the answering respondent in this regard.



4. 5. Discrepancies if any in the affiliation orders, same may be intimated to undersigned within 15 days after the date of issue of order.



ITI shall further proceed as per the following norms/ guidelines issued by DGT:

- All new ITIs and the ITIs which are due for Re-Affiliation shall comply to DGT norms of 4 trades and 12 units (Accreditation/ Affiliation in 3rd shift is not allowed) with Trade Diversity as mentioned earlier.
- Existing ITIs which are due for Re-Affiliation shall follow the Renewal of Affiliation Norms and adhere to it strictly.
- ITIs which are having space constraint for fulfilment of running with Minimum 4-trades will have following option:
  - They are allowed to have bifurcated campus within 1 kms of area as per DGT Affiliation Norms.
  - Vertical Expansion of Building is allowed as per the Building codes of the State
  - The space constraint of the existing ITI's could be resolved by shifting of the ITI's to the new location. Shifting outside the block will only be allowed when 111 shifts for the purpose of fulfilment of 4 trade criteria and that too, it is shifting to an under-served area (less than 170 trainees in the block) as verified by state/UT Director.
- All the ITIs shall comply with 4 Trades criteria before the start of session 2023
