Subject: De-affiliation of trades/units of ITIs (Government & Private) whose 100% seats are lying vacant from last 5 years (2018 to 2022) -Regarding.

Sir/Madam.

This is regarding updation of data pertaining to number of available seats in ITIs available in the NCVT portal.

As you are aware, the NCVT portal is used for managing the entire life cycle of ITI trainees from admission to the certification. It is seen that for various reasons, over the years, discrepancies have creeped into the data, particularly regarding the number of seats in the ITI ecosystem.

The data available on the NCVT portal is used to provide information on various fora, including Parliament questions and Parliament Standing committees, Cabinet Secretariat, PMO etc.

In addition, this data is now being used for grading the ITIs across the country. Therefore, it is imperative that this data be accurate and updated.

An analysis was done to identify the number of seats / trades/ units where no admissions have taken place in the last five years. It is seen that as on date there are over 30000 affiliated units (a seating capacity of around 6.5 lacks) in which there are zero admission for more than past 5 years (state wise list is enclosed in Annexure-A).

As per provisions, contained in DGT letter # DGT-12/01/2018-TC (Part) dated 20.12.2018, any trade or unit has zero admission continuously for two consecutive years, the unit / trade is deemed to be de-affiliated. So, these trades/units need to be de-affiliated.

You are requested to go through the data and invite objections from respective ITIs pertaining to your state (Govt. as well as Pvt ITIs) and state your consolidated comments, if any to the deaffiliation of these units/trades.

If no comments are received from the State Directorate within a period of **six weeks** from the date of the issue of this letter, the DGT will assume that the concerned state/UT has no objection and those units would be de-affiliated as per norms.
