Whereas the Petitioner-Institute has prayed Hon'ble court to quash the impugned order dated 08. 11.2019 passed by the respondent. The Petitioner-Institute further seeks a direction to the Respondents for granting them affiliation in respect of 'Electrician' trade for academic session 2020-21 in a time-bound manner.

- 2. Whereas the, the Hon'ble High Court vide its order dated 18.07.2022 in WP 7438/2020, has observed that
 - "...the Petitioner-Institute is permitted to give fresh response(s) to the Respondents against the SCNs issued by DGT noted above, within a period of two weeks from today and DGT shall thereafter, decide the same and pass a speaking order thereon, within a period of six weeks...".
- 3. That in compliance with the aforesaid order, ITI reply dated 28.07.2022 has been reconsidered and a joint verification has been conducted by RDSDE and State Directorate of Uttar Pradesh on date 25.04.2023.
- 4. That findings of the joint verification report received from RDSDE and State Directorate of Uttar Pradesh were discussed in 10th Standing Committee on Accreditation and Affiliation (SCAA) held on from 16.06.2023 to 23.06.2023. SCAA has recommended Electrician trade 4 (2+2) units from session 2023-24 onwards, same has been approved by competent authority.
