Sub: De-affiliation of VRB Private ITI (PR22000147) Chhattisgarh.

Sir / Madam,

VRB Private ITI has applied for addition of Electrician trade - 4 (2+2) units. But during inspection it was found that ITI has shifted to new location without the approval of DGT and concerned State Directorate. Matter of this ITI was discussed in 5th Standing Committee on Accreditation and Affiliation (SCAA) meeting held on 16.08.2022 and addition of trade/unit was not recommended as ITI has shifted without permission of DGT/State.


State Directorate of Chhattisgarh vide letter dated 19.04.2023 has recommended de-affiliation of VRB Pvt ITI as ITI has shifted without permission of the State Directorate and DGT. Also, as per clause 3.5 of affiliation norms 2018, If any existing institute relocates to a new location without following latest NCVT norms or without written prior approval of DGT/ State Directorate, then institute shall be de-affiliated.

The matter was discussed in 10th meeting of (SCAA) held on 16.06.2023 to 23.06.2023. Subsequently, SCAA has recommended de-affiliation of all trade/units of this ITI, same has been approved by competent authority. The details of given below:
