Sir / Madam,

With reference to letter dated 11.04.2023 by State Directorate of Training and Employment (DTE) Uttarakhand to Acumen Private ITI & Suryadev, Paramedical Private ITI, wherein it was informed to both the ITIs that they have changed their location without adhering to the relevant rules and provisions.

As per clause 3.5 of affiliation norms 2018, If any existing institute relocates to a new location without following latest NCVT norms or without prior written approval of DGT/ State Directorate, then institute shall be de-affiliated.

Further, RDSDE, Uttarakhand had issued Show cause Notices (SCN) dated 01.05.2023 to Acumen Private ITI and Suryadev Paramedical Private ITI. In response to which, Acumen Private ITI has sent a reply to RDSDE, Uttarakhand on date 20.05.2023 and Suryadev Paramedical Private ITI has sent reply to RDSDE, Uttarakhand on date 22.05.2023.

The matter was discussed in 10<sup>th</sup> meeting of Standing Committee on Accreditation and Affiliation (SCAA) held on 16.06.2023 to 23.06.2023. Subsequently, the SCAA has recommended de-affiliation of all trade and units of Acumen Private ITI & Suryadev, Paramedical Private ITI w.e.f. session 2023-24, and same has been approved by the competent authority. The details are given in below:
