**Sub: De-affiliation Order of Maharana Pratap Private ITI, Chittaurgarh – (PR08000907).**

Sir / Madam,

State Directorate of Technical Education (DTE) of Rajasthan vide its letter 13816 dated 12.09.2019 has issued a Show Cause Notice (SCN) to Maharana Pratap Private ITI, Chittaurgarh, as institute found closed during inspection. ITI was asked to submit a reply to the SCN but State DTE Rajasthan has not received any reply from the Maharana Pratap Private ITI, Chittaurgarh.

Whereas a SCN was also issued to Maharana Pratap Private ITI by DGT on 26.06.2020 to which ITI has replied on 06.08.2020. Reply of ITI was discussed in discussed in 4<sup>th</sup> Standing Committee on Accreditation and Affiliation (SCAA) held on 26.10.2021 and committee decided to conduct joint inspection of the ITI.

Further, joint Inspection of the said ITI was conducted by RDSDE and State DTE Rajasthan on 08.07.2022, but Institute was found closed and the Principal of the institute has conveyed that there are no Equipment & Machinery as per NCVT Norms in the institute.

State Skill Development and Entrepreneurship Committee (SSDEC) Rajasthan in 3<sup>rd</sup> meeting held on 10.01.2023 has recommended de-affiliation of Maharana Pratap Private ITI, Chittaurgarh.

This matter was discussed in 10<sup>th</sup> meeting of SCAA held on 16.06.2023 to 23.06.2023 and based on the SSDEC's recommendation, SCAA has recommended de-affiliation of all trade and units of Maharana Pratap Private ITI, Chittaurgarh w.e.f. session 2023-24, same has been approved by the competent authority. The details are given in below:
