Sir / Madam,

State Directorate of Technical Education (DTE) of Rajasthan vide its letter 10045 dated 13.01.2021 has issued a Show Cause Notice (SCN) to Vishwakarma Private ITI, as Irregulates were found during NCVT Exam in November, 2020.

Whereas a SCN was also issued to Vishwakarma Private ITI by DGT on 15.06.2021 to which ITI has replied, same was discussed in 4<sup>th</sup> Standing Committee on Accreditation and Affiliation (SCAA) held on 26.10.2021 and committee decided to conduct joint inspection of the ITI. Further, joint Inspection of the said ITI was conducted by RDSDE and State DTE Rajasthan on 01.06.2022, but it was found that ITI is physically not present at the address mentioned on NCVT MIS portal.

Whereas findings of joint inspection were discussed in 3<sup>rd</sup> meeting of State Skill Development and Entrepreneurship Committee (SSDEC) of Rajasthan, held on 10.01.2023, and committee has recommended de-affiliation of Vishwakarma Private ITI, Jaipur.

That the matter was discussed in 10<sup>th</sup> meeting of Standing Committee on Accreditation and Affiliation (SCAA) held on 16.06.2023 to 23.06.2023 and based on the SSDEC's recommendation, SCAA has recommended de-affiliation of all trade and units of Vishwakarma Private ITI, Jaipur w.e.f. session 2023-24, same has been approved by the competent authority. The details are given in below:
