## OFFICE MEMORANDUM

Subject: Regarding compliance of Cont case 964/2023 in the Hon'ble Delhi High vide Court Order dated 16.05.2023 passed in W.P.(C) 14570/2022 titled as Maa Santoshi Pvt ITI & ANR Versus DGT.

Whereas, the petitioner i.e, Maa Santoshi Pvt ITI (Code:TMP 408 MSTI) has filed the above subject writ petition for seeking relief to grant of affiliation for 4 units (2+2) of Electrician Trade in the Multi Skill Training Institute (MSTI) category from the academic session 2022-23, which was rejected in 5<sup>th</sup> SCAA meeting held on 16.08.2022 to 18.08.2022 due to certain deficiencies.

- 2. Whereas, after hearing contention of the both the parties, the Hon'ble court has disposed-off the writ petition on 16.05.2023 with a direction to the respondent-DGT, for fresh consideration of the petitioner application from the Academic Year 2023 in time bound manner.
- 3. Whereas, the petitioner vide letter dated 05.06.2023 submitted the response to the deficiencies highlighted in the minutes of meeting of 5<sup>th</sup> SCAA. Thereafter the petitioner case was placed before the 10th SCAA meeting held in the month of June 2023 and it was decided in the said meeting that the resolution of the deficiencies will have to be certified by the Joint inspection committee and further to check all other the infrastructure as per affiliation norms.
- 4. Whereas, the benefits of MSTI scheme is available for the applicant ITI which is lying under unserved area. The joint inspection was conducted on the premises of the petitioner institute on 02.08.2023 and the inspecting team considered the grant of the affiliation to the petitioner subject to de-affiliation of the Zawar Hussain Private ITI (PR10000858), having zero admission in last 02 consecutive years which is present in the same block of the petitioner institute.
- 5. Whereas, DGT issued a notification on 23.06.2023 to initiate de-affiliation proceeding against the ITIs whose 100% seat are lying vacant from last 05 academic years. The aforesaid Zawar Hussain ITI is annexed in the list of Annexure B of this letter. So, the de-affiliation proceedings is already initiated against this ITI and same will be dealt as per de-affiliation rules.

Therefore, in view of the above, the petitioner institute is granted affiliation of Electrician trade in 4 (2+2) units from the session 2023.

This issues with approval of competent authority and in compliance to judgement dated 16.05.2023 in WPC 14570/2022.
