Subject: Uploading Instructor details on NCVT-MIS portal - regarding

Sir/ Madam,

In continuation to our letter no. DGT-MIS013/2/2023-O/o DIR (TC) dated January 25, 2023, and subsequent email of a date extension for uploading instructor details on the NCVT-MIS portal dated March 2, 2023, it is observed that only 98,775 instructor details have been uploaded as of this date out of 2,06,920 sanctioned. This indicates huge vacancies in ITIs (government and private), which clearly depicts the poor performance of the ITIs.

The Parliamentary Standing Committee on Labour, Textiles, and Skill Development has recently taken up this matter and expressed its serious concern. Also, the same issue was raised in many forums as a serious concern and questioned the quality of training imparted in ITIs across the country.

In this context, it is decided to keep the NCVT-MIS portal open 24 hours a day, 7 days a week, for uploading instructor details until further orders. Accordingly, all the state directorates are requested to issue the necessary directions to all the ITIs (government and private) in your jurisdiction and ensure that all the ITIs upload the instructor details for every trade, shift, and unit (TSU). All the state directorates can monitor instructor vacancies in ITIs under their jurisdiction through the NCVT-MIS dashboard through following link: <https://www.ncvtmis.gov.in/Pages/Dashboard/InstructorDashboard.aspx>.

DGT may initiate a special drive before the start of every admission cycle to deactivate respective units that do not have instructors as per the NCVT-MIS portal, and admission will not be allowed in those units. These units would be treated as de-affiliated and de-activated on the portal without any separate de-affiliation procedures.



The NCVT-MIS-MIS portal is active for uploading the instructor details 24x7 until further orders, and ITIs can upload the instructor details through their creator and approver logins by following the guidelines provided in the user manual along with this letter.

This issues with the approval competent authority.
