## Sub: De-affiliation Order for ITIs of Gujarat State recommended for de-affiliation in 11th SCAA.

Sir / Madam.

With reference to the Minutes of 2<sup>nd</sup> SSDEC meeting of Gujarat State held on 05.07.2022 wherein de-affiliation of trades/units of 41 ITIs were recommended.

The matter was discussed in 8th SCAA, and the committee informed the concerned RDSDE to submit the details of these ITIs in prescribed format to DGT. Subsequently, the details have been received from the concerned RDSDE and the same was further discussed in 11th SCAA, which was held from 28.08.2023 to 30.08.2023.

Based on the recommendations of SSDEC and information shared by RDSDE, SCAA has recommended the de-affiliation of trades/ units of 18 ITIs as mentioned in the list attached at Annexure 1, w.e.f. session 2023-24, and the same has been approved by the competent authority. Details of these 18 ITIs are attached at Annexure - 1.

The Institute and State Directorate shall ensure that all the trainees who were already enrolled in previous sessions, complete the training duration and no fresh trainees are admitted.
