- AND whereas it is stated that the Petitioner made the application for affiliation on 14.04.2022 That as per the "Affiliation Norms of 2018", the accreditation/affiliation process comprises of three stages. The stages of the affiliation process are given herein below-:
 - a) In the Stage I, the application of the Institute has to be scrutinized by the concerned State, in which the ITI is located, inclusive of but not limited to checking location, trade/units and authorized person's details.

b) Subsequent to the completion of the Stage - I, the desktop assessment of the Institute has to be conducted by the State Directorate after which a Letter of Intent has to be issued for the Stage -

- c) The Stage III of the Affiliation process comprises of the inspection of the premises of the Institute by the State Directorate and the DGT Officials after which an ICVC (Inspection cum Verification Committee) report is to be submitted to this Directorate General.
- AND whereas the application of the Petitioner Institute is pending at the stage of desktop assessment with the State Directorate. It is pertinent to mention that the letter of Intent, has to be issued after the completion of the desktop assessment. The role of this Directorate General starts after the issuance of the Letter of Intent. The role/duty of the State Directorate cannot be surpassed by the Directorate General of Training as vocational training falls under the purview of concurrent list, as per allocation of Business Rules.

Therefore, the petitioner Institute is hereby informed that this Directorate General can't consider its application for affiliation until the State Directorate conducts the mandatory activity of desktop assessment on NIMI affiliation portal. Yours faithfully
