OFFICE MEMORANDUM

Subject: Regarding compliance of CONT.CAS(C) 1392/2023 arisen in Order dated 19.04.2023 passed in WPC 11602/2022 titled as Maa Saraswati PVT ITI & ANR Versus DGT.

Whereas, the petitioner (i.e Maa Saraswati Pvt ITI Bhaluani Deoria, code-TMPOLD312) from Uttar Pradesh was not recommended in the meeting of the 1st Standing Committee on Accreditation and Affiliation (SCAA) held on 04-05.04.2022 due to the deficiencies observed in the petitioner institute. Being aggrieved with aforesaid decision the petitioner has filed the above subject writ petition, seeking relief to quash the decision of SCAA and further to decide the application for grant of affiliation for 4 (2+2) Units of Electrician Power Distribution and 4 (2+2) Units of Early Childhood Educator from the Academic Session 2022-23 in a time bound manner.

2. Whereas, the Hon'ble court disposed of the matter on dated 19.04.2023 with a direction to the respondent to reconsider the application and to take final decision on the petitioner's application in a time-bound manner from session 2023-24.

3. That, in compliance of above order, the petitioner was given a prior intimation on 05.06.2023 to carry out the inspection and the petitioner case was considered in 10th SCAAA meeting held on 16.06.2023 to 23.06.2023. It was decided in SCAA to carry out the inspection within 30 days and submit the NoC for the MSTI within 30 days from 21.07.2023. Meanwhile, the petitioner moved the above subject contempt petition in non-compliance with the order dated 19.04.2023 passed in the writ petition 11602/2023.

4. That, the joint inspection was scheduled on 26.09.2023 as per the availability of officials from the State Directorate and RDSDE and a special dispensation was made to the petitioner to admit trainees until 15.10.2023. The inspection was carried out for the 2 (1+1) Units of Electrician Power Distribution as per request of the petitioner institute.

5. That, the inspecting team has not recommended the application for affiliation and again pointed out some deficiencies. Subsequently, the petitioner institute was afforded an opportunity to rectify the deficiencies and directed to submit the report along with NOC for the institute to consider it under MSTI scheme, via email dated 27.09.2023. The petitioner has submitted the report along with documentary evidences to DGT on 29.09.2023. Moreover, in response to the NoC for MSTI, the petitioner has also submitted a signed copy of document from state directorate indicating the block area Bhaluwani as unserved.

6. That, the reply submitted by petitioner institute was sent for further verification to RDSDE and the verified report was submitted by RDSDE with below observation- "As per the layout plan given by ITI, breadth and length of drawing hall is 15'2" and 33' respectively (Drawing Hall area is 501.6 sq ft equivalent to 46.6 sqm). The area is less than the required norms of 50 sqm. As per photographs and video sent by ITI, electrical



machineries are still not properly installed. The information provided in respect of teaching and other staff is incomplete."

7. That, the benefit of the MSTI scheme is limited to the institute opened in the unserved area only, which should be certified by concerned state directorate. It is pertinent to mention that state directorate Uttar Pradesh vide its email dated 07.10.2023 has confirmed that- "*NOC submitted by the petitioner ITI is not genuine. Currently, the Bhaluwani Block is considered served.*"

8. That, the petitioner institute couldn't rectify all the deficiencies observed in 1st SCAA meeting held on 04-05.2022 (such as building plan, machinery installation and instructors) despite having ample time and also having an opportunity afforded via email dated 27.09.2023 after the 2nd time inspection on 26.09.2023 and has even attempted to mislead the DGT by submitting manipulated documents (Building plan and NOC for MSTI)

Therefore, in view of above iterated circumstances, the petitioner application is hereby "*Not Recommended*" for grant of affiliation for 4 (2+2) Units of Electrician Power Distribution and 4 (2+2) Units of Early Childhood Educator.

This issues with approval of competent authority and in compliance to judgement dated 19.04.2023 passed in the matter of W.P.(C) 11602/2022 and judgement date 26.09.2023 passed in CONT.CAS(C) 1392/2023 by the Hon'ble court.
