OFFICE MEMORANDUM

Subject: Compliance of Hon'ble High Court's order dated 18.07.2022 in WPC 14127/2021 titled New Sanskriti Pvt ITI (PR09001443) vs DGT & Others -reg

Whereas a Show Cause Notice (SCN) was issued to New Sanskriti Private ITI on date 22.10.2020 by DGT, as the ID of New Sanskriti Private ITI was found to be involved in creating fake ITIs on the NCVT MIS portal. ITI provided a reply to the SCN on 27.10.2020.

- 2. Whereas an Inspection of New Sanskriti Private ITI was conducted on 09.03.2021. As per the report, the Inspection team has reported significant deficiencies and has not recommended the ITI for affiliation. The findings of the report were discussed in the 24th meeting of the Recommendation Committee meeting held on 23.03.2021 and the Committee decided to debar the ITI from taking admissions for the year (2021) and issue another Notice to the ITI.
- Whereas second SCN was issued to the ITI on 05.07.2021 mentioning deficiencies found during the inspection of the ITI. ITI has replied to the 2nd SCN vide email dated 14.07.2021. Further another SCN was issued to the ITI on date 15.09.2021, as the ID of the ITI was found to be involved in the illegal mapping of trades/units/addresses on the NCVT Portal for other ITIs on the NCVT MIS portal, to which the ITI has replied on 17.09.2021.
- Whereas ITI has filed a Writ petition (WPC 14127/2021) in the High Court of Delhi praying to quash 4. the impugned order dated 06.04.2021 passed in 24th RCM passed by the DGT in relation to the ITI and permit the ITI to admit trainees against the sanctioned seats and conduct the said course from academic session 2021-23. Hon'ble High Court vide its order dated 18.07.2022 has given the following directions to DGT:
- "... to pass a speaking order on the show cause notices dated 05 July, 2021 and 15th September 2021, within a period of two months from today. The concerned adjudicating authority would consider the reply of the Petitioner Institute and issue appropriate orders uninfluenced by any of the observations made here in above."
- Whereas, in compliance with the Hon'ble High Court order dated 18.07.2022, the reply of ITI to SCN dated 05.07.2021 and 15.09.2021 has been reconsidered but was found unsatisfactory, as some deficiencies still existed in the documents submitted by ITI according to the affiliation norms of 2018. Subsequently, the ITI was given an opportunity to rectify these deficiencies, and as per the report received from the RDSDE and the concerned State Directorate on 04.09.2023, ITI has successfully addressed all the deficiencies mentioned in SCN dated 05.07.2021.
- However, a complaint has been registered by DGT with the cyber cell regarding the unauthorized addition of trades/units and the creation of ITIs on the NCVT MIS portal using the ID of New Sanskriti Private ITI. The outcome of this case is currently pending.

7. That based on the report submitted by RDSDE and State Directorate UP, the competent authority has decided to restore the affiliation status of Electrician trade - 4 (2+2) units and Fitter trade -4 (2+2) units, as per affiliation order dated 25.09.2012 for the New Sanskriti Private ITI. The ITI is allowed to admit trainees from session 2023-24 onwards.

8. However, the affiliation granted to New Sanskriti Private ITI is subject to the outcome of the complaint registered in the cyber cell. If in case, it is found that ITI has been involved in the unauthorized access and mapping of trade/units/addresses on the NCVT MIS portal then ITI will be permanently de-affiliated.

2. This issues with the approval of competent authority and in compliance with the Hon'ble Court's

judgment dated 18.07.2022.
