**OFFICE MEMORANDUM**

**Subject: Compliance of interim judgement dated 23.09.2023 passed in the matter of WPC 15798/2022 titled THE NAVODAYA ITC ITI Vs DGT & Ors. at the bench of Bengaluru-reg**

Whereas, the petitioner i.e. Navodaya ITC (PR29001144) has filed Interlocutory Applications (IA) in above writ petition for seeking a direction to the respondent - authorities to permit the petitioner – Institution to admit the students for the academic year 2023-24 at shifted location.

2. And whereas, the Hon'ble High Court at Bengaluru Bench in I.A. No.1/2023 vide order dated 23-09-2023 in WP No. 15798/2022 directed the respondents "*to permit the petitioner therein to admit the students for the academic year 2023-24 subject to the condition that the petitioner – Institution will submit an application seeking affiliation within 10 days and the respondent - authorities shall keep the on-line portal active to enable the petitioner – Institution to upload the application seeking affiliation and if such application is received by the authorities, it is open for the concerned authorities to examine the application and take further course of action in accordance with law.*"

3. And whereas, earlier the Hon'ble court has passed the similar interim direction in the connected matters in WPC 18850/2022 on 26.06.2023 by providing the relief to the petitioner to provisionally admit the trainees in session 2022-23 along with a rider to apply for affiliation on the NIMI portal.

4. That in compliance to above interim judgment date 26.06.2023, DGT vide email dated 08.08.2023 has allowed the petitioner to provisionally admit the trainees and upload the data on NCVT portal, made during the session 2022-23. The petitioner was also afforded the opportunity to apply on the online portal from 18.08.2023 to 17.09.2023 to make an application in order to regularise the affiliation at shifted location as per latest regulation.

5. Subsequently, the petitioner has applied on the NIMI portal on 14.09.2023. The petitioner application shall be decided by the State Directorate by completing the desktop assessment and subsequent joint inspection at the premises of the petitioner institution. On completion of the joint inspection, the application shall be put up before Standing Committee on Accreditation and Affiliation (SCAA) for taking final decision of affiliation.



Therefore, in view of above circumstances, it has been decided that the relief is extended for the petitioner to the extent for taking admission and uploading the data of admitted trainees on portal, made during the academic Session-2023-24, as per timelines of academic calendar issued by DGT. It is worth mentioning here that these admissions are provisional in nature and subject to final outcome of the writ petition. So, the Petitioner-institution shall take an undertaking from the students that they will not claim any equity since their admission are subject to result of the writ petition.

This OM shall not be taken as precedence in any other matters.

This issues with the approval of competent authority and in compliance to interim judgement date 23.09.2023 passed by the Hon'ble Court.
