Subject: - Online compliance module on NIMI affiliation portal

Applications for accreditation/affiliation of ITIs are invited through the NIMI Affiliation portal, and the Standing Committee on Accreditation and Affiliation (SCAA) takes the final decision on affiliation. During the decision-making process, the SCAA provides the ITI applicant with an opportunity to rectify any deficiencies found, and the ITI/State/RDSDEs are asked to submit a compliance report. Currently, these compliance reports are received in the DGT via email and physical letters. However, this method presents challenges in terms of monitoring and processing affiliation applications in a timely manner.

2. To address this issue, DGT has introduced the online compliance module on the NIMI Affiliation portal (<https://nimionlineadmission.in/iti/>). This module offers an efficient and convenient way to submit compliance reports, aiming to increase transparency, accountability, and the timely resolution of affiliation applications.
3. User manuals specifically designed for the States, RDSDEs, and ITIs to provide comprehensive guidance on using this online compliance module are attached herewith. It is essential for all stakeholders to familiarize themselves with the functionalities of this compliance module.
4. Henceforth, all concerned States, RDSDEs, and ITIs can submit the compliance report within the stipulated time as per the SCAA remarks, using the online compliance module only.
5. All stakeholders must adhere to the timelines set by the SCAA and compliance reports submitted after the timelines or through other means will not be accepted by the DGT.
