**Subject:** Opening of NIMI Affiliation portal for session 2024-25.

This is regarding opening of NIMI affiliation portal for inviting applications for new affiliation / accreditation of ITIs for session 2024-25. As you are aware, the Directorate General Training (DGT) invites applications for the accreditation and affiliation of Industrial Training Institutes (ITIs) through a designated affiliation portal called the NIMI portal. These applications are filled in three stages followed by Desktop Assessment (DA) after each stage by the concerned State Directorate. In the past, NIMI portal was opened in years 2020, 2022 and 2023 and it has been observed that around 1,145 affiliation applications which were received in these years are still pending for DA at State Directorate level.

2. It may be noted that applications received on NIMI portal are processed on a first come first serve basis, i.e., until DA on all the application received in session 2020 is not started, DA on applications received in subsequent sessions cannot be started. According to this principle, new applications received cannot be considered for affiliation till the backlog is completed, and are relegated to the end of the queue leading to increase in the processing time and perpetuating a cycle of delayed processing affiliation application.

3. Now for session 2024-25, DGT intends to open NIMI affiliation portal for inviting affiliation applications in the month of February / March, 2024. However, considering the backlog of pending applications at the DA level, all the State Directorates/UTs are requested to indicate their willingness on the same to DGT within 15 days from the date of issue this letter.


4. If no reply is received from the State / UT, it will be assumed that the State / UT is not interested in inviting affiliation applications for the 2024-25 session, and consequently, the affiliation portal will not be opened for applications from those States/UTs.

5. In this regard, States/UTs will have to send the letter through mail on email id tc-affiliation@dgt.gov.in with a copy to ujjwal.biswas28@gov.in.
