Sir/Madam,

The data migration activity for trainees admitted in various CTS courses for the 2023 session has been completed from state admission portals to the DGT portal (SID platform) by 12th January 2024, as per the DGT schedule (copy attached).

We have received numerous representations from State/UT Directorates and NSTIs regarding pending data migration of trainees who were admitted before 10th October 2023 but were not migrated to the SID portal due to various issues/errors.

After careful consideration of all the requests, the competent authority has decided to provide a final opportunity for trainee data migration to the DGT portal (SID) through API/Excel as per the mentioned schedule.

Furthermore, the cut-off date for the "Trainee Verification process" on the new DGT portal (SID) has been extended from 29th February to 30th March 2024, considering the challenges faced by the trainees.
