Subject :- Regarding the compliance of judgement dated 22.11.2022 passed by the Hon'ble court in W.P.(C) No. 805/2021 titled Gida Private ITI Versus DGT in Delhi High Court at Delhi.

This is regarding W.P.(C) No. 805/2021 titled Gida Private ITI Versus DGT in Delhi High Court at Delhi filed by Gida Pvt. ITI for seeking directions inter-alia to quash the de-affiliation order dated 28th January 2021.

2. The Hon'ble High Court of Delhi vide its order dated 22.11.2022 in WP 805/2021 disposed of the matter inter alia directing that :

"...10. Accordingly, impugned decision dated 22nd October, 2020 and deaffiliation order dated 28th January, 2021 are set-aside qua Petitioner-Institute. The de-affiliation order dated 28th January, 2021 shall be treated as showcause notice and Petitioner-Institute shall be permitted to file a reply/response thereto, within a period of three weeks from today. In case, DGT requires any clarification from Petitioner-Institute, the same shall be communicated and response thereto shall be given forthwith. Thereafter, DGT shall pass a speaking order thereon, as expeditiously as possible, preferably within a period of four weeks from the receipt of response from Petitioner-Institute. In the event the Petitioner-Institute is aggrieved by the DGT's decision, it shall be at liberty to take recourse to such remedies as are available under law. The Court has not expressed any opinion on the merits of the case. All rights and contentions of the parties are left open.

11. DGT shall take a decision uninfluenced by any observations made hereinabove.

12. With the above directions, the present petition, along with pending application, is disposed of."

3. That, in compliance to Hon'ble Court dated 22.11.2022, the representation dated 02.10.2023 from petitioner ITI was reconsidered and a joint inspection has been conducted by the State Directorate and RDSDE U.P on 24.04.2024.

4. That, based on the joint inspection report received, the competent authority has approved to revoke the de-affiliation order dated 28.01.2021 qua Petitioner- Institute (Gida Pvt ITI; PU09900476) and to restore the status of petitioner ITI trades/units in shifts 1 and 2, i.e. Fitter - 4 (2+2) and Electrician - 4 (2+2) on the NCVT MIS portal. However, as per DGT order issued on 09.01.2023 (copy attached), the third shift will only be restored after the ITI submits the details of the MOU with industries as per DST guidelines through State Directorate.

This issues with the approval of competent authority.

Sub: De-Affiliation of 77 Private ITIs/Trades/Units of Uttar Pradesh

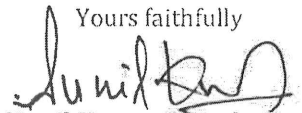
Sir,

Letter no. 2733/T-3/RP/S/De-affiliation/2018 dated 03.10.2018 from the Director Training & Employment, Lucknow, Uttar Pradesh addressed to DG (T) regarding de-affiliation of 115 ITIs in the State of Uttar Pradesh. Subsequently, DGT had issued show cause notices to 115 ITIs seeking for reply. On scrutiny, the replies of 108 ITIs were not found justified. The matter of de-affiliation of these ITIs was placed before the 2nd Recommendation Committee Meeting held on 28.03.2019 at agenda point No.2.4., and committee recommended for de-affiliation. Before issue of De-affiliation order, decision of recommendation committee was challenged by some ITIs in Hon'ble Courts. The matter was then reviewed in 4th Recommendation Committee Meeting held on 28.05.2019. It was decided that the said ITIs will be taken up for joint inspection and decision will be taken based on Inspection report.

Further In addition to 108 ITIs, 19 more ITIs were included for Joint Inspection for De-affiliation based on the complaints received against these ITIs, The State forwarded the report along with remarks for recommended for de-affiliation. Committee approved the recommendation as given by the Standing Committee as per remarks mentioned in 10th Recommendation Committee Meeting-DGT dt. 15.10.2020 at agenda item no 10.1. The List of de-affiliated ITIs with deficiencies as per Joint Inspection Committee report is attached.

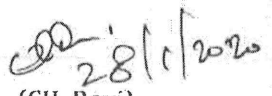

In continuation to letter DGT-11012/4/2021-O/o DIR (TC) dated 26.07.2021, it is to inform that:

1. The affiliation of trade/units in 3rd shift in new /existing ITIs will be allowed in Dual System of training (DST) mode only.
2. For Existing units in 3rd shifts, ITIs will have to convert to DST mode gradually over a period of two years i.e. by session 2024.

This will promote DST mode in ITIs, thereby strengthening Industry linkages and acquainting trainees with latest technologies used in the Industry and thus enhancing their employability by making them industry ready.

This issues with the approval of Competent Authority.

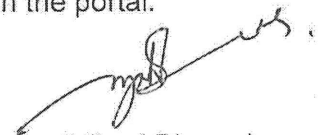
