OFFICE MEMORANDUM

Subject: Final Compliance of the Hon'ble Court judgement dated 13.05.2024 passed in W.P.(C)6449/2024 titled New Shershah ITC Vs Directorate General of Training & Anr and other connected matters

Whereas the 06 writ petitions were filed at the juncture of the Hon'ble court of Delhi seeking the direction to verify the trainee's data admitted during session 2022 and 2023 and subsequent upload the same on NCVT portal.

2. Whereas the Hon'ble court has disposed of these connected matters on 13.05.2024. The relevant para of judgement passed in WPC 6449/2024 is extracted as hereunder-

"6. Accordingly, this writ petition is disposed of in the following terms:

i) The State Directorate of the State of Bihar is directed forthwith, and during the period the NIMI portal of State Directorate is operational, to verify the data relating to the 64 students/trainees in the electrician and fitter trades admitted by the petitioner institution and, in respect of the students who are eligible, forward the data online to the NCVT-MIS Portal of the DGT.

(ii) The DGT would, after perusing the said data forwarded by the State Directorate, issue a user ID and password to the petitioner.

7. The DGT is directed to proceed with the matter and provide the user ID and password to the petitioner as expeditiously as possible and, at any rate, on or before 31 May 2024."

3. That in compliance to the aforesaid judgement dated 13.05.2024, the state directorate of Bihar was requested vide DGT email dated 21.05.2024, to verify the eligible trainee's data claimed to be admitted by petitioner during session 2022 and 2023 as the case may be, and forward the complied list to DGT.

4. That state directorate has formed the committee vide its letter dated 1498 dated 24.05.2024, to verify the trainee data claimed by the petitioner institute. It is important to note that the verification of admission data requires matching the Aadhar card details, fee receipts, admission register, and photos of the trainees submitted by the petitioner. These litigants were given a second opportunity to complete the verification by presenting the trainees physically at the institute with a prior intimation from State and RDSDE Bihar. Despite this, four litigants were unable to provide the necessary details to the verification team, and no trainees were present physically in theses institutes, making it impossible to verify the trainee data by the verification team. Additionally, the verification team observed several other deficiencies in the machinery and infrastructure.

5. That State Directorate vide its letter No-1814, Dated-26.06.2024 has approved and forwarded the verified list of 116 trainees for 02 litigants and



rejected the data of admission for 04 litigants. Therefore, as per State report, the following decision has been made by DGT in compliance judgement dated 13.05.2024-



6. It is pertinent to mention here that DGT has introduced new admission Skill India Digital Hub (SIDH) portal for taking admission from session 2023 onwards. The examination related activities are also being carried out on the SIDH portal. The data of trainees admitted on NCVT portal for session 2022 is being transferred to SIDH for carrying out exams. The AITT exam is scheduled to be held in August 2024 for the regular trainees of academic year 2022 and 2023. So the petitioner institutes are directed to carry out the verification process of admitted trainees immediately after data upload and the complete the exam related activities starting from 30.06.2024. In case any error occurs while data upload, the

petitioners shall provide the correct details through state directorate in time bound manner.

This issues with approval of competent authority in compliance of judgement dated 13.05.2024 passed in W.P.(C)6449/2024 titled New Shershah ITC Vs Directorate General of Training & Anr and other connected matters.
