This is reference to letter from State Directorate of Rajasthan dated 30.10.2023 in which the State Directorate has recommended the de-affiliation of Dev Guru Private ITI.

ITI was designated as self-centre for AITT Exam conducted in July 2023 but during inspection conducted by flying squad it was found that the ITI has been shifted to another place without taking prior approval from DGT and State.

Whereas, a show cause notice was also issued to Dev Guru Private ITI by the State Directorate on 21.08.2023 to which ITI has replied on 02.09.2023. The reply of the ITI was considered but as ITI has shifted to new location without approval of DGT and State, the State Directorate has recommended de-affiliation of the Dev Guru Private ITI vide its letter dated 30.10.2023.

That, based on the State Directorate recommendations, the competent authority has recommended de-affiliation of Dev Guru Private ITI, Bundi w.e.f session 2024-25. The details are given below:
