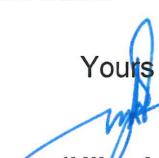
The Institute and State Directorate shall ensure that all the trainees who were already enrolled in the previous session, complete the training duration and no fresh trainees are admitted.

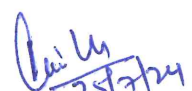
