OFFICE MEMORANDUM

Subject: Compliance of interim judgement dated 12.07.2024 passed by the Hon'ble Court in the matter of WP NO. 101706/2022- Sri Siddeshwar Educational Trust and Ors Vs DGT and other connected matters at Dharwad Bench-reg

Whereas, in batch of writ petition WP 101706/2022 (Main) and 03 other connected matters, by the interim order dated 22.04.2022, 26.06.2023, the Hon'ble court has granted interim relief to permit the petitioners – Institutions to take up the admission of the students at the shifted place for the academic year 2021-22 and 2022-23 respectively.

- 2. Whereas, the below mentioned petitioners have filed another application seeking similar directions and permission to admit the students for the academic year 2023-24 and to permit them to take up the ensuing examination.
 - i. W.P. No. 101706/2022- Sri Siddeshwar Educational Trust and 2 others
 - ii. W.P. 105863/2022-Sri Siddeshwar educational Trust ITI
 - iii. W.P. No. 102421/2023- Shree Jadagiyothi Basayeshwar Education Society and 7 others
 - iv. W.P. No. 103333/2023- Sri Shree Pandit Panchaxari, Shree Vaishnavi Pvt ITI
- 3. Whereas, the Hon'ble court vide the interim order dated 12.07.2024, in aforesaid writ petitions has allowed the application and as a last chance, directed the respondent's authorities to permit the students, who have already been admitted to take up the ensuing examinations for the academic year 2023-24. Further the Hon'ble court directed the petitioners that compliance to all the norms prescribed by the respondents authorities are to be met with by the end of August 2024.
- 4. Therefore, in compliance to above interim judgment date 12.07.2024, it has been that the aforesaid petitioner institutes are allowed to admit the students in the portal for academic Session 2023-24 and to take the ensuing examinations. It is pertinent to mention that these admissions are provisional and subject to final outcome of the writ petitions so the Petitioners-institutions shall take an undertaking from the students that they will not claim any equity since their admission are subject to result of the writ petitions.
- 5. That the petitioners are directed to approach the state directorate along with the necessary data and documents of the admitted trainees within 07 days from the issue of this OM in order to regularize the admission on the portal. The State Directorate has to consolidate the list of trainees and forward it to DGT in the standard template, both in signed PDF and Excel format, immediately thereafter.
- 6. After receiving valid trainee data, DGT shall facilitate the petitioners to carry out the trainee's verification in order to generate the permanent registration number (PRN) on SIDH portal. Since the exam related activities such as attendance and marks upload, formative assessment, exam fess, HT download and center mapping etc. has already been started in portal for the ensuing examination 2024, the admitted trainees shall be allowed to take the examination by following the exam guidelines in the next batch of supplementary or leftover examinations due to technical constraint.
- 7. It is pertinent to mention that, as per the interim direction of the Hon'ble Court in WPC 1775/2022 at the Bengaluru Bench, the DGT opened the NIMI Portal from 18.08.2023 to 17.09.2023 to invite applications for regularizing affiliations at shifted locations for 64 ITIs, including the petitioners in the aforementioned case.

This decision was communicated to the petitioners via email on 17.08.2023, with a subsequent reminder email sent on 04.09.2023. The portal was reopened from 23.11.2023 to 29.11.2023 and again in 2024. However, it has been observed that only three petitioners have applied for the regularization of shifting despite providing multiple opportunities. The brief details of such litigants are provided in **Annexure-1**.

- 8. So, in compliance with the Hon'ble Court's interim order dated 12.07.2024, and in adherence to the principles of natural justice, a last and final opportunity is hereby granted to the petitioners to regularize their affiliation by applying on the NIMI portal. The portal will be open from 29.07.2024 to 28.08.2024 under category-1 (New Institutes seeking Affiliation for new trades/new units) and category-4 (Change of Site location) for the institutes listed in **Annexure-2**.
- 9. That the applicants whose shifting is within the municipal corporation area in urban areas or within a block in rural areas should apply under category-4. Others should apply afresh for new institutions under category-1. Their applications shall be processed in accordance with the shifting guidelines issued on 30.06.2023 (Copy attached) and affiliation norms 2018. Furthermore, petitioners whose affiliations remain un-regularized, shall not be permitted further admissions, with the liberty to the Hon'ble Court's direction.

This OM shall not be treated as precedent in other matters.

This issues with the approval of competent authority and in compliance to interim judgement dated 12.07.2024 passed by the Hon'ble Court.

Office Memorandum

Subject: - Clarification on Shifting/relocation of an Institute (Change in geotagging location of the Institute) guidelines-reg.

To streamline the existing shifting guidelines and ensure clarity, better understanding among all stakeholders, it has been decided to issue comprehensive guidelines that clarify the process and norms for the shifting/ relocation of ITIs.

The guidelines are as follows:

- 1. In the case of rural areas, an ITI can only be shifted within the same block, while in urban areas, it can only be shifted within the same municipal/ corporation limits. The norms/ guidelines applicable in this case are as follows:
 - i. The ITI can shift/relocate with the same trades which are currently affiliated at old location.
 - ii. The ITIs affiliated, prior to affiliation norms 2018, will be exempted from the land requirement as given in chapter 2- Civil norms for ITIs affiliation -2018, clause 1.2, point a & b. However, the institutional requirements such as classrooms, workshops, IT labs, and drawing halls, as well as administrative area requirements, must comply with the latest norms. The trade infrastructure should adhere to the norms of the latest syllabus of the trades, issued by DGT from time to time.
 - iii. ITI should obtain NoC (No Objection certificate) from State before applying for shifting. If any existing ITI relocates/shifts to a new location without NoC then ITI shall be de-affiliated at old location and not be allowed to re-affiliate for minimum period of 3 years from the date of de-affiliation.
 - iv. After obtaining the NOC, the ITI can apply online on the designated online portal and follow the entire process of affiliation that involves desktop scrutiny, inspection by an inspection team, and a final decision on the application by SCAA (Standing Committee on Accreditation and Affiliation).
 - v. When an ITI applies for shifting to a new location, it must ensure that all enrolled trainees complete their training duration and all training-related activities (i.e., practical, CBT exams and any other exam related activities) at the old location, and no fresh admissions are allowed. The machinery can

- be shifted to the new location only after the training and training related activities of enrolled trainees is completed at the old location.
- vi. During the shifting process, the ITI may utilize all movable existing equipment, machinery, tools, etc. However, all machinery should be in working and safe condition to facilitate practical training to the trainees.
- vii. In the case of shifting as per provision of this letter, ITI will be exempted from following:
 - a. ".... All the tax invoices of machinery, equipment, and tools shall not be older than six months from the date of application....".
- viii. After receiving the shifting application from the ITI on the designated online portal, ITI at old location will be made temporarily inactive on NCVT MIS portal.
 - ix. ITI will only be allowed to take admission at new location if its application of shifting is recommended by SCAA and session will be decided as per DGT academic calendar.
 - x. If the shifting of the ITI at a new location is not recommended by the SCAA, then the institute shall not be allowed to continue at either of the locations.
 - xi. An ITI is not eligible to apply for shifting within 5 years from the date of its establishment.
- xii. Any ITI which is completely de-affiliated by DGT, shall not be eligible to apply for relocation/shifting.
- xiii. Addition of trades/units shall not be allowed along with shifting/relocation of an ITI.
- xiv. The minimum grading criteria for addition of trade/units shall not be applicable in the case of shifting/ relocation of an ITI.
- 2. Shifting/ relocation of existing ITI outside the block/ municipal corporation limits is not permitted. If an ITI intends to shift outside the block/municipal corporation limits, then it may apply afresh as new ITI by following latest norms.
- 3. If in any case ITI has to shift/relocate due to forced majeure (Force majeure, means situations where natural disasters like cyclone, natural fire/wildfire, flood, war, earthquake, tsunami, drought, or any other nature-caused calamity, which affected the regular operation of the institute.) then it will be dealt as an exceptional case with the approval of competent authority.
- 4. The Multi Skill Training Institute (MSTI) are not allowed to shift as the benefit of MSTI scheme is limited to unserved area only with some relaxation in affiliation norms 2018. Likewise, the ITI opened in spare capacity of Polytechnic/ Engineering college are also not allowed to shift/ relocate.
- 5. The shifting applications which have already been decided, will not be reopened. The applicant ITI may apply afresh to get affiliation as per provision made in this office memorandum.

The above guidelines supersede all previous guidelines/orders, including the order no. DGT-MoM/11/2019-O/o Dir (TC) dated 18.09.2019 and clause 3.5 of the Affiliation Norms-2018 (Change in Site/ Location of the Institution/ change in geo-tagging location of the Institution) related to the relocation/shifting of ITIs.

These guidelines shall come into effect from the date of issuance of this office memorandum.
