## **OFFICE MEMORANDUM**

Subject: Compliance of the Hon'ble Court judgement dated 24.07.2024 passed in W.P.(C) 9084/2023 titled Ekjut Private ITI Katni Vs UoI and Ors at High court of MP, Jabalpur Bench -reg

Whereas the above subject petition was filed by the petitioner i.e., Ekjut private ITI (PU23000975) seeking the relief to direct the Respondent DGT and State directorate to include the name of the petitioner institute as an affiliated institute in the portal and, to include the name of the petitioner institute in the portal regarding choice filling for the purpose of counselling for the purpose of enrolment of the student in the petitioner institute.

- 2. Whereas the Hon'ble court has disposed of the matter on 24.07.2024. The relevant para of judgement is extracted as hereunder-
- "In view of the aforesaid position, it would be just and appropriate to direct the respondent nos.3 and 4 to allow the petitioner/institute and the candidates to participate in the ongoing counselling. The fate of the counselling and admission, if any, made in the petitioner institute would be subject to final decision taken by the competent authority in respect of affiliation of the petitioner. In case, the petitioner is ultimately dis-affiliated, then the proper arrangements shall be made in respect of the students, if any, admitted to the petitioner/institute by the competent authority and in such eventuality the petitioner/Institute shall be liable to return the fee and other charges received from the candidates/students"
- 3. Whereas, the petitioner institute is de-affiliated vide DGT order 30.07.2024 based upon the decision taken in 17<sup>th</sup> SCAA meeting held on 15.07.2024. Therefore, the petitioner institute is not allowed to take admission w.e.f. session 2024-25 onwards.
- 4. That in compliance to the Hon'ble court's direction, trainees admitted by the petitioner institute during the 2024-25 session will be transferred to other recognized institutes in coordination with the state directorate. The following steps will be followed for the transfer process:
  - i. The petitioner shall submit the trainees' details to the state directorate of MP within 7 days from the issuance of this letter. The submission must include the trainees' basic details, Admission Receipt number, and the amount of fees collected from them. Additionally, the petitioner shall provide an undertaking to the state directorate stating

- that all fees and charges received from the trainees have been returned to concerned, in compliance with the Hon'ble Court's direction.
- ii. Thereafter, the state directorate will identify 2-3 nearby recognized institutes willing to admit these trainees. The trainees admitted by the petitioner institute can take fresh admission in these recognized institutes based on eligibility and by depositing the required fees.
- iii. The data of the admitted trainees will be transferred to DGT through the State Admission Portal to SIDH to generate their PRN.
- iv. It is important to note that DGT shall not be responsible for any disputes that arise between the petitioner and its admitted trainees over fees, charges, or any other matters.
