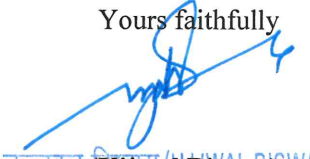
The Institutes and the State Directorate shall ensure that all the trainees who were already enrolled in the previous sessions, complete the training duration and no fresh trainees are admitted.

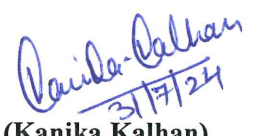
