This is in reference to minutes of meeting of 4th Skill Development and Entrepreneurship Committee (SSDEC) of Haryana State held on 26.06.2024, vide which the de-Affiliation of trade/units of Baba Ranadhir Pvt. ITI were recommended and sent to DGT.

The matter has been examined and the competent authority has decided to de-affiliate Baba Ranadhir ITI, Haryana , w.e.f session 2024-25. The details are given below:

The concerned State Directorate has issued a Show Cause Notice(SCN) to the ITI on 26.12.2022, to which no reply was received from the ITI.3. Thereafter a reminder SCN was issued on 13.01.2023, to which ITI has responded on 23.01.2023.4. In its response, the ITI explained that the entire Bhuna region, including the ITI, had been affected by heavy rainfall, leading to the relocation of the institute to a building on Hisar Road, Model Town.5. It was further stated that, on the day of inspection, bus services were unavailable, and the roads were blocked by the people of Bhuna. The ITI requested permission to use the relocated building until 31.07.2023 to allow for renovations at the approved location.6. The matter was discussed in 3rd SSDEC held on 13.07.2023 and it was decided to conduct a joint inspection. The SSDEC also approved the action of the department to withhold the admissions of this ITI for academic session 2023-24.7.
