Sir / Madam,

This is in reference to minutes of meeting of 4th Skill Development and Entrepreneurship Committee (SSDEC) of Haryana State held on 26.06.2024, vide which the de-Affiliation of trade/units of **Shri Krishna Pvt. ITI** was recommended and sent to DGT.

The matter has been examined and the competent authority has decided to de-affiliate **Shri Krishna Pvt. ITI**, Haryana , w.e.f session 2024-25. The details are given below:
