Madam/Sir,

This is in reference to minutes of meeting of 8th Skill Development and Entrepreneurship Committee (SSDEC) dated 09.12.2024 & 10.12.2024, and 9th SSDEC of Madhya Pradesh held on 27.02.2025, vide which the de-affiliation of 25 Pvt. ITIs were recommended and sent to DGT.

The matters were discussed in 21st Standing Committee on Accreditation and Affiliation (SCAA) held on 28.04.2025 and based on the recommendations of SSDEC, SCAA has recommended the de-affiliation of trade/units of 10 Private ITIs w.e.f. session 2025-26, and same has been approved by the competent authority. The details of 10 ITIs are attached at **Annexure - I**.

The recommendation of de-affiliation of ITIs, as mentioned in attached list must be read in conjunction with the minutes of 21st SCAA meeting.

The Institutes and the State Directorate shall ensure that all the trainees who were already enrolled in the previous sessions in these ITIs, complete the training duration and no fresh trainees are admitted.

Further, the ITI is debarred from submitting any application for a period of three years from the date of issuance of this office order.
